## 2023 Annual Newsletter

### 2023 Membership dues will increase.

A Copy of the proposed amendment to the constitution must be sent by United States mail to each club member in good standing at least ten (10) days prior to the annual meeting. At the annual meeting a quorum of the club membership eligible to vote must be present and the amendment must be approved by an affirmative vote of those present.

Club members in good standing must be notified by email, social media, and website, at least ten (10) days prior to the annual meeting of the proposed amendment to the constitution. At the annual meeting a quorum of the club membership eligible to vote must be present and the amendment must be approved by an affirmative vote of those present.
